



## Senate Act

**Act No: SA-20-05**

**Act Title: To Appropriate Funding to Support Fall 2019 UHWO Cap & Gown Initiative**

BE IT ENACTED BY THE UNDERGRADUATE SENATE:

1 SECTION 1: PURPOSE

2 The Associated Students of the University of Hawai'i – West Oahu was chartered by the  
3 Board of Regents to act as the student government representing all classified undergraduate  
4 students. The purpose of this bill is to provide funding support for the Fall 2019 UHWO  
5 Cap & Gown Initiative. By doing so, ASUHW O can work with the Commencement  
6 Committee to provide funds to help alleviate the financial cost of purchasing cap and  
7 gown attire for seniors that are participating in the Fall 2019 Commencement Ceremony,  
8 who are not able to financially purchase them. The purchase of a Cap and Gown will be  
9 returned with five days to be reused for each future UHWO commencement ceremony.

10 SECTION 2: APPROPRIATIONS

11 A total of \$900 shall be appropriated from the Senate for the purchase of  
10 Cap and Gown Initiative ..... \$900.00

12 SECTION 3: PROVISIONS

13 ASUHW O shall be recognized as a sponsor for funding for this event. Guidelines are as  
14 follows: Eligible graduating seniors will apply for Cap and Gown initiative through a google

15 form questionnaire. Students must provide an explanation as to why they should be chosen to  
 16 use the Cap and Gown service. Students who are selected will need to follow the borrow  
 17 requirements and will need to sign a promissory note. In the event, a student fails to return the  
 18 cap and gown, or any part of the set, the student will be charged accordingly. The cap, gown,  
 19 and tassel attire is a total of \$41.95

20 SECTION 4: ASUHWO Treasurer is authorized to handle the monies appropriated.

21 SECTION 5: This act shall take effect upon confirmation by the Senate.
